NOTICE TO PWD CANDIDATES

It is for information of candidates of PWD category who have applied for the post of Contractual TG Teachers, in response to **Recruitment Notice No.9383, Dt. 23.02.2019** of Director Secondary Education, Odisha that, facility of scribe for assisting in appearing the recruitment examination is available only to those PWD (Persons with Disability) candidates who are visually impaired or have any such disability thereby preventing them to write or properly operate the Computer Based Test (CBT) platform. Such PWD candidates who desire to avail the facility of using scribe and if permitted for the same shall arrange their own scribe and the cost of the scribe if any, shall be borne by the candidate.


The scribe should be of +2/12th Class and must not be from same discipline as that of the candidate. For example, for a candidate applying for TGT PCM/ CBZ post, the scribe must be of class +2/12th in Arts discipline and similarly for a candidate applying for TGT Arts, the scribe must be of class +2/12th in Science discipline. The copy of certificates of Educational Qualification and Original Photo Id (Aadhar/ Voter I Card) of the scribe needs to be produced at examination center for verification by the Center Superintendent as well as Observer, if any.

Candidates willing to avail the facility of scribe need to apply to the Director, Secondary Education, Odisha with required information as well as Photo of Candidate and scribe in the prescribed format given below on or before **16.04.2019, 5.00PM** through email dsehelpdesk2019@gmail.com. PWD candidates who desire to avail the facility of using scribe are also required to submit the photocopy of their Disability Certificate issued by Competent Authority while sending application to Director, Secondary Education, Odisha for facility of scribe. The ink signed original application shall be produced at the Examination Center along with copy of disability certificate.

Besides, all PWD Candidates, including those who apply for facility of scribe shall have to produce the original Disability Certificate issued by Competent Authority at the Examination Centre for verification and also to submit a photocopy of the same to the Center Superintendent of the respective Examination Center.

No candidate can avail a scribe without permission of Director, Secondary Education, Odisha.

Any request for permission to use scribe, received after 16.04.2019, 5.00 PM shall not be entertained. Application without signature (Full) shall not be accepted.
